# Wings Over Florida Rules

The "Wings Over Florida" bird program awards full color certificates at seven achievement levels to birdwatchers who report their life and/or big year lists to the Florida Fish and Wildlife Conservation Commission's Great Florida Birding and Wildlife Trail. This program is a free service to all.

### Official Rules

- 1. No Exotic species can be counted (see below).
- 2. All birds counted towards your certificate total must be
  - a. seen and/or heard in Florida (Pelagic species count if seen in Florida waters).
  - b. Alive and wild when observed. NOTE: Birds escaped from a zoo or collection do not count.
  - c. Seen and/or heard by the person submitting the application.
- 3. Only one individual per application.
- 4. This program runs on the honor system. However, Red-cockaded Woodpecker, Mangrove Cuckoo and Florida Big Year certificate applicants may be asked to provide supporting documentation via email. An applicant's eBird checklist for example would qualify as supporting documentation.
- 5. All species seen and/or heard were done so in an ethical manner. For more information on birding ethics visit the American Birding Association code of ethics webpage **listing.aba.org/ethics/**

Nonnative (exotic) species, established or non-established are **NOT** countable towards your Wings Over Florida total. The following 15 species have been confirmed as established exotics in Florida: Egyptian Goose, Muscovy Duck, Rock Pigeon, Eurasian Collared-Dove, Gray-headed Swamphen, Monk Parakeet, Nanday Parakeet, White-winged Parakeet, Redwhiskered Bulbul, European Starling, Common Myna, Spot-breasted Oriole, House Finch, House Sparrow. There are many more non-established exotics in Florida (too numerous to list) which also do not count towards this program. ### **Certificate Levels**

#### Florida Life List

This list includes all the bird species (excluding exotics) you have seen within your lifetime within the state of Florida.

Ruby-throated Hummingbird (25 to 49 species)
Roseate Spoonbill (50 to 99 species)
Florida Scrub-Jay (100 to 199 species)
Crested Caracara (200 to 299 species)
Red-cockaded Woodpecker (300 to 399 species)
Mangrove Cuckoo (400+ species)

## **Big Year List**

This list includes all the bird species (excluding exotics) you have seen in Florida between January 1 and December 31.

NOTE: We print your final Big Year total on to your certificate so try to see as many species as possible within the qualifying dates.
